## THE SONS OF GOD (Genesis 6:1-2)

## I. The IDENTITY of the "SONS of GOD" (6:1-2)

- A. LIBERAL interpretation--only MYTH and SUPERSTITION
- B. First NATURALISTIC interpretation
  - 1. "Sons of God" are KINGS and NOBLES, and "daughters of men" are COMMONERS
  - 2. Problem was intermarriage of ROYALTY and PEASANTS
- C. Second NATURALISTIC interpretation
  - 1. "Sons of God" are descendants of SETH, and "daughters of men" are descendants of CAIN
  - 2. Problem was intermarriage of BELIEVERS and UNBELIEVERS
  - 3. SUPPORTED by fact "sons of God" often refers to BELIEVERS (Jn 1:12; Rom. 4:18; etc.)
  - 4. WEAKNESSES
    - a. Neither descendants of SETH nor true BELIEVERS previously referred to this way
    - b. Hebrew *bene elohim* refers to ANGELIC BEINGS in ALL other uses (Job 1:6; 2:1; 38:7)
    - c. Related phrases *bar elohim* (Dan. 3:25) and *bene elim* (Pss. 29:1; 89:6) also refer to ANGELS
    - d. Grossly OVERSIMPLIFIES the pre-Flood population
    - e. Intermarriage of BELIEVERS and UNBELIEVERS unlikely to produce MIGHTY GIANTS

- D. SUPERNATURALISTIC interpretation
  - 1. "Sons of God" are ANGELIC BEINGS, and "daughters of men" are HUMAN WOMEN
  - 2. Problem was the attempt of FALLEN ANGELS to prevent the coming of the PROMISED SEED by CORRUPTING the human race
  - 3. SUPPORT
    - a. "Sons of God" seems to indicate ANGELS
    - b. Classic interpretation of ALL WRITERS until Chrysostum and Augustine (including the LXX)
    - c. May explain the MIGHTY GIANTS as OFFSPRING
    - d. ANGELS sometimes identified as "MEN," often APPEARING and ACTING as men (Gen. 18:8; Heb. 13:2; etc.)
  - 4. Questions
    - Can ANGELS cohabit with HUMANS and produce OFFSPRING? (Matt 22:30?)
    - b. Would their offspring have been MUTANT HUMANS or a MONGREL RACE, and what about their SOULS?
- E. Probable solution
  - 1. SATANIC ANGELS compounded original rebellion by cohabiting with HUMAN WOMEN, "whomever they chose" (cf. Jude 6-7)
  - 2. They may have done so by "possessing" HUMAN MEN to produce DEMONICALLY CONTROLLED and GENETICALLY ALTERED humans
- II. Consequences Wrought by the "SONS of GOD"
  - A. Produced a "race" of MIGHTY GIANTS (Heb. *nephilim*)
  - B. Provoked God to DESTROY most of HUMANITY to preserve the line of the PROMISED SEED
  - C. Provoked God to CONFINE these particular DEMONS in *Tartarus* to be "reserved forJUDGMENT" (1 Pet. 3:19-20; 2 Pet. 2:4)
